ACTIONS TAKEN:

- 1) Council approved the agenda for the PH & Regular Meeting 6/27/22 as received.
- 2) Council approved the minutes of the PH & Regular Meeting of 6/13/22 as received.
- 3) Council approved to pay the claims for Cherokee County in the amount of \$328,618.90.
- 4) Chairman Spencer opened the public hearing Ordinance No. 2022-15 to amend the Agreement for Development for Joint Co. Industrial Park by & between Spartanburg & Cherokee Counties so as to include additional property in Sptg. Co. as part of the Joint County Industrial Park, and other matters relating thereto. No one was present to speak.
- 5) Council went into Executive Session at 5:06 PM pursuant to Section 30-4-70(a)(5) for Project Treeline. Council came out of Executive Session at 6:32 PM. No action or vote was taken.
- 6) Council adopted Resolution 2022-10 amending the Agreement for development of Joint Co. Industrial/Business Park by & between Cherokee & Spartanburg Co.
- 7) Council adopted Resolution 2022-11 identifying a project to satisfy the requirements of Title 12, Chapter 44 of the SC Code so as to allow investment expenditures incurred by a company known as Project Treeline.
- 8) Council adopted Resolution 2022-12 changing the Fee Schedule.
- 9) Council adopted 3rd Reading of Ordinance No. 2022-15 to amend the agreement for Development for Joint County Industrial Park by & between Spartanburg & Cherokee Counties so as to include additional property in Spartanburg Co.
- 10) Council adopted the 3rd Reading of Ordinance No. 2022-04 adopting a FYB for 22/23 beginning 7/1/22 and ending 6/30/12 for the Cherokee Co. General Budget as amended.
- 11) Council adopted the 3rd Reading of Ordinances adopting a FYB for 22/23 beginning 7/1/22 and ending 6/30/12 for the following: No. 2022-05 Antioch Fire District; No. 2022-06 Buffalo Fire District; No. 2022-07 Cherokee Creek Fire District; No. 2022-08 – CKC Fire District; No. 2022-09 Corinth Fire District; No. 2022-10 The Gaffney Fire District; No. 2022-11 Grassy Pond Fire

- 12) Council passed the motion to allocate \$15,000 to CHAPS from the Local Accommodations Sales Tax monies.
- 13) Council adopted 1st Reading of Ordinance No. 2022-21 authorizing the execution & delivery of a FILOT Agreement by & between Cherokee Co. & Project Treeline.
- 14) Council adopted 1st Reading of Ordinance No. 2022-22 authorizing & approving the Development of a Joint County Industrial & Business Park for Project Treeline.
- 15) Bid No. 2022-16 Scrap Metal at Landfill – no bids were received. Will rebid again.
- 15) Council passed the motion to pass the 22/23 Capital Request Budget in the amount of \$3,977,795.49 and to allow Administrator Bratton to use \$651,182 monies from the American Rescue Plan to balance this budget.
- 14) As there was no other business to come before council at this time, the meeting was adjourned at 6:10 pm.
