- 1) Council adopted the agenda for the Regular Meeting of 11/21/22 as received.

- 3) Council approved to pay the claims for Cherokee County in the amount of \$245,201.28.
- 4) Councilman Tracy McDaniel presented a plaque to the Blacksburg High School Marching Band and their Director Shane Dixon.
- 5) Council approved the motion to adopt the County Council Meeting Schedule for 2023 as presented.
