- 4) Council approved the motion to award RFP for 2023-08 Cherokee Co. Comprehensive Land Use Plan & Unified Development Ordinance to include implementation of zoning to Benchmark, Charlotte, NC for a total of \$242,725.00.
- 5) Council approved the motion to award Bid 2023-09 Flooring at the Law Enforcement Center to JMT Commercial Flooring, Inc., Greenville, SC. for their low bid of 34,495 and to pay the difference in the bid price of \$8,495 from the Contingency Fund.
