- 4) Council approved to pay the claims for Cherokee County in the amount of \$689,775.94.
- 5) Council heard from Anthony Wilson.
- 6) Chairman Spencer opened the public hearing on 3 ordinances: 1) No. 2022-27 to amend & update certain parts of the Cherokee Co. Code of Ordinances Chapter 13 Land Development Regulations; 2) No. 2022-28 to amend & update certain parts of the Cherokee Co. Code of Ordinances Chapter 15 Article V Campgrounds & Recreational Vehicle Parks; and 3) No. 2022-30 to amend the Agreement for Development for Joint Co. Industrial Park by & between Spartanburg & Cherokee Counties, so as to include additional property in Spartanburg Co. as part of the Joint Co. Industrial Park.
