ACTIONS TAKEN:

- 1) Council adopted the agenda for the Regular Meeting of 10/2/23.
- 2) Council approved the minutes of the Regular Meeting of 9/18/23 as received.
- 3) Council approved the claims to be paid for Cherokee County in the amount of \$811,945.64.
- 4) Council approved the motion to adopt the 2nd Reading of Ordinance No. 2023-20 to provide for the repeal of the Solid Waste Collection User Fee and references thereto set forth in the budget ordinance No. 2023-03, and to amend Ordinance No. 2023-03, being the budget ordinance for the County for the fiscal year ending 6/30/24, and to provide for other matters related thereto.
- 5) Council approved the motion to distribute the Accommodations Tax monies according to the Committee's recommendation of \$49,864 for the 11 applicants.
- 6) Administrator Bishop opened Bid No. 2024-02 Landfill Scrap Metal. 3 bids were received: 1) Metal Recycling Service, Gastonia, NC; 2) Owen Electric DBA CMC Recycling, Dallas, TX; and 3) Custom Recycling, LLC/Doug Jaffray, York, SC. These were placed in the PWC for review.
- 7) Administrator Bishop opened Bid No. 2024-03 Limb & Brush Grinding. 3 bids were received: 1) Greentree; 2) State Tree Service, Inc. Sumter, SC; and 3) Farmer's Mulch & Rock, Inc. Dobson, NC. These were placed in the PWC for review.
- 8) Administrator Bishop made comments regarding Policy on Public Comments. Attorney Mathis and I are still checking into a policy regarding our public comments and will bring it back to council for adoption soon.
- 9) Administrator Bishop reported that the county tax bills will be mailed out the week of Oct. 23, 2023, and taxes are due on or before Jan. 16, 2024.

- 10) Administrator Bishop reported Open Enrollment has begun for our employees and will run through Oct. 31, 2023. Any changes that are made during this open enrollment will take effect on Jan. 1, 2024.
- 11) Attorney Mathis reported on a request from Milliken requesting the SCDOT transfer ownership & maintenance responsibility of S-670 (Milliken Road) from S-83 Blacksburg Highway to end the state maintenance to Milliken. Cherokee Co. has the right of first refusal and if you do not reply then SCDOT will proceed to transfer ownership & maintenance to Milliken as requested. Council took no action and will not reply.
- 12) As there was no other business to come before council at this time, Chairman Spencer adjourned the meeting at 5:20 PM.
