All locks will be repaired and/or replaced and adjusted according to the manufacturers recommended tolerance.

Door position switches will be checked, repaired, or replaced as needed.

Items to be installed:

Southern Steel (or equivalent) locks 7 on the outside of all doors as required by the Minimum Standards for Jails in South Carolina

All cylinders must be replaced to create a completely New Key Schedule with no less than four complete sets of keys including 10 copies of any Master Keys.

2) Keys must be security keys that cannot be duplicated except by special order (i.e. not by a local locksmith or Walmart style kiosk)

Preventative Maintenance requirement:

All locks will be cleaned, lubed and adjusted according to the manufacturers recommended tolerance.

Intercoms and door position switches will be checked and adjusted according to the current conditions

Air system checked each visit: PM including oil change will be performed 2 times per year.
