<u>State Ethics Filings:</u> Candidates are required to file a Statement of Economic Interests and a Campaign Disclosure online with the State Ethics Commission at http://ethics.sc.gov. Failure to file these documents may result in a candidate fine but will not disqualify a candidate from the election. Contact the State Ethics Commission for more information.

Notice of Election:

The Non-Partisan Special Election for the City of Gaffney City Council District 1 (unexpired term) will be held Tuesday, December 31, 2024. Any person wishing to vote in this election must be registered by December 1, 2024, **AND** live in City Council District 1 for at least 30 days prior to election. Please visit www.scvotes.gov for more information or call 864-487-2563.

Early voting will take place at the Cherokee County Board of Voter Registration and Elections located at 110 Railroad Ave, Gaffney, SC 29340, starting on Monday, December 16, 2024, and ending Friday, December 27, 2024. Hours are Monday-Friday 8:30am-5:00pm. Will be closed for holidays December 24-26, 2024.

Deadline to request AND return an absentee by mail application is Friday, December 20, 2024, at 5:00pm. Please call the Voter Registration Office at 864-487-2563 for information.

Any runoff will be held two weeks after the election on Tuesday, January 14, 2025; early voting would be Wednesday, January 8, 2025 through Thursday, January 10, 2025, 8:30am-5:00pm

Voters will be asked to provide one of the following Photo IDs when voting in person:

- S.C Driver's License
- ID card issued by the DMV
- S.C. Voter Registration Card with Photo
- Federal Military ID
- Concealed Weapons Permit

At 9:00 a.m. on December 31, 2024, the Cherokee County Election Commission will begin examining the absentee ballot return envelopes. This examination will be held at the Cherokee County Election Commission office located at 110 Railroad Avenue in Gaffney, SC 29340.

On Friday, January 3, 2025 at 9:00 a.m., the County Board of Canvassers will conduct a hearing to determine the validity of all provisional ballots cast in these elections. This hearing will be held at the Cherokee County Election Commission office.

ONLY voters who are registered by December 1, 2024 and reside in the City of Gaffney Council District 1 for at least 30 day prior to election are eligible to vote in the Special election. Due to the limited number of registered voters, precincts will be combined for this election only.
