1. You must be fingerprinted by a local law enforcement agency. The fingerprint card must be filled out completely.
2. **As specified by Section 15-49-20 of the South Carolina Code of Law: the attached Affidavit must be completed and notarized before submitting to SLED.**
3. Please complete Records Check Name Change Form CJ-054.
4. Twenty-five dollar (\$25.00) fee. PAYMENT MUST BE MADE TO SLED BY BUSINESS CHECK (SOUTH CAROLINA ONLY), CERTIFIED CHECK, CASHIER'S CHECK OR MONEY ORDER FOR THE CORRECT AMOUNT ONLY. *CASH and PERSONAL CHECKS WILL NOT BE ACCEPTED.
5. You must enclose a self-addressed postage paid envelope or the return of your request(s) will be delayed.
