

NOTICE OF ELECTION
STATE OF SOUTH CAROLINA COUNTY OF CHEROKEE

A Non-Partisan Municipal Election will be held on Tuesday, November 4, 2025, for the City of Chesnee to elect Mayor and two (2) city council persons.

Any person wishing to vote in this election must be registered by:

- In person is 5:00 p.m. on Friday, October 3, 2025.
- Online registrations and registrations submitted by email or fax must be received no later than 11:59 p.m. on Sunday, October 5, 2025
- Applications by mail must be postmarked no later than Monday, October 6, 2025.

Early Vote:

Early voting will take place at the Cherokee County Board of Voter Registration and Elections located at 110 Railroad Ave, Gaffney, SC 29340, starting on Monday, October 20, 2025, and ending Friday, October 31, 2025. Hours are Monday-Friday 8:30 a.m.-5:00 p.m.

Any runoff will be held two weeks after the election on Tuesday, November 18, 2025; early voting would be Wednesday, November 12, 2025, through Friday, November 14, 2025; Canvass would be Thursday, November 20, 2025 @ 9am.

Absentee by Mail:

The deadline to request & return an Absentee By-Mail application is 5pm on Friday, October 24, 2025. Please contact our office @ 864-487-2563 or visit us in-person to request an absentee application.

Voters will be asked to provide one of the following Photo IDs when voting in person:

- S.C Driver's License
- ID card issued by the DMV
- S.C. Voter Registration Card with Photo
- Federal Military ID
- Concealed Weapons Permit

Voters should remember to bring one of these IDs with them to the polling place. Voters without Photo ID can get one free of charge from their county voter registration office or the Department of Motor Vehicles. Voters who encounter an obstacle to getting a Photo ID should bring their paper voter registration card without a photo to their polling place. These voters can then sign an affidavit swearing to their identity and to their obstacle to obtaining a Photo ID and vote a provisional ballot. This ballot will count unless the county board of voter registration and elections has grounds to believe the affidavit is false. At 9:00 a.m. on November 4, 2025, the Cherokee County Election Commission will begin examining the absentee ballot return envelopes. This examination will be held at the Cherokee County Election Commission located at 110 Railroad Avenue in Gaffney, SC 29340.

On Thursday, November 6, 2025, at 9:00 a.m., the County Board of Canvassers will conduct a hearing to determine the validity of all provisional ballots cast in this election. This hearing will be held at the Cherokee County Election Commission.

The following precinct (s) and polling place (s) will be open on election day from 7:00 a.m. until 7:00 p.m. Polling places are subject to change under certain conditions. Voters can check their assigned polling place at scVOTES.gov before going to the polls.
