

The Board of Voter Registration and Elections of Cherokee County announces the Nonpartisan General Election for the Spartanburg County School District 2 to be held on Tuesday, November 4, 2025, to fill the following offices:

The last day to register in-person at the Cherokee County Voter Registration and Election Office located 110 Railroad Ave, Gaffney, SC, 29340, is Friday, October 3, 2025, at 5:00 PM. Online registrations and registrations submitted by email or fax must be received no later than 11:59 p.m. on Sunday, October 5, 2025. Voter registration by mail forms will be accepted if postmarked by Monday, October 6, 2025. To vote in Cherokee County, you must be a resident of Cherokee County and reside within the Spartanburg County School District 2.

The early voting period for this election begins on Monday, October 20 and ends on Friday, October 31. The following early voting centers will be open during the early voting period from 8:30 AM until 5:00 PM, Monday through Friday:

Voters will be asked to provide one of the following Photo IDs when voting in person.

- S.C. Driver's License
 - Includes standard License and REAL ID
- S.C. Department of Motor Vehicles ID Card
 - Includes standard ID card and REAL ID
 - Includes SC Concealed Weapons Permit
- S.C. Voter Registration Card with Photo
- Federal Military ID
 - Includes all Department of Defense Photo IDs and Veterans Affairs Benefits Card
- U.S. Passport
 - Includes U.S. Passport ID Card

If you have one of these Photo IDs, you are ready to vote. Voters should remember to bring one of these IDs with them to the polling place. Voters without Photo ID can get one free of charge from the Department of Motor Vehicles or their county voter registration office. Voters who encounter an obstacle to getting a Photo ID should bring their paper voter registration card without a photo with them to their polling place. These voters can then sign an affidavit swearing to their identity and to their obstacle to obtaining a Photo ID and vote a provisional ballot. This ballot will count unless the county board of voter registration and elections has grounds to believe the affidavit is false. At 9:00 AM on November 4, 2025, the County Board of Voter Registration and Elections will begin its examination of the absentee ballot return envelopes Cherokee County Voter Registration and Elections Office @ 110 Railroad Ave, Gaffney, SC, 29340.

On Thursday, November 6, 2025, at 9:00 AM the County Board of Canvassers will conduct a hearing to determine the validity of all provisional ballots cast in these elections. This hearing will be held at Cherokee County Voter Registration and Elections Office @ 110 Railroad Ave, Gaffney, SC, 29340.

Any Runoff will be held two (2) weeks after the Election on Tuesday, November 18, 2025, if necessary. The hearing to determine the validity of ballots challenged in the Runoff will be held on Thursday, November 20, 2025 at 9:00 AM at 110 Railroad Ave, Gaffney, SC, 29340.

Early voting for any Runoff Election, if necessary, begins on Wednesday, November 12 and ends on Friday, November 14. The following early voting centers will be open during the Runoff early voting period from 8:30 AM until 5:00 PM daily:
