Any person wishing to register to vote in this election must do so no later than January 11, 2026 at 11:59 PM. Voter Registration by Mail forms will be accepted if postmarked no later than Monday, January 12, 2026. To register, one must contact the Cherokee County Voter Registration & Elections Office or visit www.scvotes.gov.

Registered electors who cannot vote in person may be eligible to vote by absentee ballot. Absentee applications must be requested and returned by Friday, January 30, 2026. Voters wishing for more information concerning absentee voting should contact the Cherokee County Voter Registration & Elections Office at (864) 487-2563.

Voters will be asked to provide one of the following Photo IDs when voting in person.

If you have one of these Photo IDs, you are ready to vote. Voters should remember to bring one of these IDs with them to the polling place. Voters without Photo ID can get one free of charge from the Department of Motor Vehicles or their county voter registration office. Voters who encounter an obstacle to getting a Photo ID should bring their paper voter registration card without a photo with them to their polling place. These voters can then sign an affidavit swearing to their identity and to their obstacle to obtaining a Photo ID and vote a provisional ballot. This ballot will count unless the county board of voter registration and elections has grounds to believe the affidavit is false.
